GENERAL RULES & REGULATIONS

1. Rules

The 23rd SEA Games Badminton Competition will be conducted in accordance with the IBF Rules & Regulations. In case of a disagreement in the interpretation of rules from versions in different languages, the English text will prevail. Any unforeseen incident not covered by the IBF Rules shall be dealt with accordingly in the following manner:

- 1.1.** Technical questions shall be resolved in accordance with the IBF Rules.
- 1.2.** Cases of general nature shall be resolved in accordance with the SEA Games Federation (SEAGF) Statutes and Rules (2005). Particularly, the following rules shall have precedence:

SEAGF Rule 31 – Eligibility Code

To be eligible for participation in the SEA Games, a competitor must comply with the SEA Games Federation Statutes and Rules as well as Rule 45 and the By-Laws to Rule 45 of the Olympic Charter.

SEAGF Rule 32 – Nationality of Competitor

Only nationals of the country of the NOC shall be qualified to represent the NOC in the Games. All disputes relating to the determination of the country which competitor may represent in the SEA Games shall be resolved by the Executive Committee in accordance with the By-Laws to Rule 46 of the Olympic Charter.

SEAGF Rule 34 – Medical Code:

- a. Doping violation as defined by the WADA Code is forbidden.

- b. All competitors are liable to medical control and examination carried out in conformity with the rules of the International Olympic Committee Medical Commission, the WADA Anti-Doping Code and Explanatory documents.
- c. Competitors in sports restricted to women must comply with the prescribed tests for femininity, when needed.
- d. Any competitor refusing to submit for a medical control or examination or is found guilty of an Anti-doping violation shall be excluded from the SEA games. The principles of exclusion for teams and individuals shall be in accordance with the WADA Code.
- e. A medal may be withdrawn by order of the Executive Committee on the proposal of the Chairman of the Organizing Committee.
- f. A Medical Commission as approved by the Medical Committee of the SEAG Federation will be set up to implement these rules. Members of which be nominated by their respective NOC as approved by the Medical Commission of the SEAG Federation.
- g. The above regulations shall in no way affect further sanctions by the International Federation.

SEAGF Rule 38 – Number of Entries:

The maximum number of entries from each nation in each event is fixed by the Federation in consultation with the Host NOC. However, the following numbers cannot be exceeded:

- a. For individual events, including singles and doubles event, there shall only be two (2) entries from each NOC (excluding reserves). For the sports of Arnis, Bodybuilding, Boxing, Judo, Karate-do, Muay, Pencak Silat, Taekwondo, Weightlifting, Wrestling, and Wushu, there shall only be one (1) entry per weight category from each NOC, and for Sailing where there shall only be one (1) entry per event from each NOC. Any event with three (3) or more members to make up a team shall be deemed to be a team event, and there shall only be one team (entry) from each NOC.
- b. For team events, one (1) team per nation, the number of reserves shall not exceed the number of players allowed by the International Federation.
- c. For events where both team and individual competitions are conducted at the same time, the competitors for any one NOC cannot win more than two (2) medals in their respective individual events.

SEAGF Rule 41 – International Federation:

- a. The Organizing Committee shall write to the International Federation or the Asian Sports Federation concerned for their permission to hold their sport in the Games. The Organizing Committee may invite a representative who shall arrive at least three (3) days before the beginning of the first event of their sport in order to check the facilities and equipment and arrange the entries, which conform to its rules and the rules of the SEAGF.
- b. The Organizing Committee shall pay the accommodation, meals and local expenses of its representative at the established rate of the Organizing Committee until two (2) days after the closing of their competition.
- c. In exceptional cases, if for technical reasons the presence of additional delegates is necessary, the appropriate arrangements shall be made with the Organizing Committee; the Executive Committee must be previously informed. In case of disagreement, the Executive Committee shall decide.

SEAGF Rule 42 – Technical Officials and Jury of Appeal:

- a. The necessary Technical Officials (referees, judges, umpires, timekeepers, inspectors, etc.) and a Jury of Appeal for each sport shall be appointed by the appropriate National Federation of the Host Country, which shall direct their work in conjunction with the Organizing Committee.
- b. If technical officials are needed from the other Member Organizations, to be invited to the Games, the Organizing Committee shall seek approval from the Executive Committee. Should the Executive Committee approve the request, the Organizing Committee shall pay their expenses for accommodation, meals, and local transport for the whole period of the Games.
- c. The technical officials and the members of the Jury of Appeal must have never been professionals in sport.
- d. No official who has participated in a decision may serve in the Jury of Appeal that reviews it. The findings of the Jury shall be communicated as soon as possible to the Organizing Committee and the Executive Committee.
- e. Technical officials may not live in the Games Villages, but the Organizing Committee shall ensure and bear the cost of their living accommodation, including board and local transport facilities.
- f. The Jury of Appeal's decision on all technical questions concerning its respective disciplinary nature is final. They shall, however, be without prejudice to any further penalty, which may be imposed by the Executive Committee.
- g. The Jury of Appeal shall be composed of a Chairman/ woman, which position shall be filled up by the Host Country of the Games with a representative of each member country as members.
- h. The International Technical delegates to the Games may be appointed ex-officio members of the body and shall act only in an advisory capacity, unless their respective International Federation requires otherwise
- i. In the event of a dispute or protest relative to technical questions concerning its respective sporting event, representatives of countries in the Jury of Appeal whose countries are involved in the dispute or protest may be allowed to participate in the deliberations, but cannot vote in the resolution of the protest or dispute.

SEAGF Rule 43 – Court of Appeal

The Executive Committee on behalf of the Federation is the Court of Appeal, which will decide finally on all questions concerning the Games. NOCs or the Organizing Committee may submit questions to the Court of Appeal. In addition the Court of Appeal may intervene in all questions of non-technical nature outside the Jurisdiction of the Juries of Appeal set up for each sport in the programme.

SEAGF Rule 44 – Claims and Protests

- a. Claims and protests made to the judges on the grounds concerning matters of fact are decided by them without appeal. Appeals against other decisions of the Judges or with regard to any other matter must be addressed to the Chairman of the Jury of Appeal for the sport concerned by a representative of the NOC of the country making the appeal.

- b. For exceptional circumstances, any claim must be made within thirty (30) minutes of the decision giving rise to the claim. The Jury of Appeal after an investigation shall then give a decision and this decision shall be irrevocable, except for the case of a disqualification of a team or of a competitor for infraction of the Southeast Asian Games Federation, which shall be decided by the Court of Appeal. All claims and appeals must be made in writing.

SEAGF Rule 45 – Penalties in Case of Fraud:

A competitor proved fraudulently to have transgressed the Rules and Regulations of the Southeast Asian Games Federation, shall be disqualified and lose any position he/she may have gained. If this competitor's NOC is proved to have been a party to the fraud, his/her country shall be disqualified in the sport involved.

2. Participants

- 2.1. The 23rd SEA Games Badminton Competition is reserved for teams representing National Federations affiliated to the SEA Games Federation.
- 2.2. Only competitors who comply with the conditions laid down in the SEAGF Statutes and Rules (2005) and the IBF Rules are entitled to participate.
- 2.3. Each country may enter up to fifteen (15) male and fifteen (15) female competitors and four (4) officials. The total number of officials must not exceed the number of competitors in the team.

3. Entries

- 3.1. Entries in each participating country must be submitted in accordance with the regulation laid down by the Organizing Committee of the 23rd SEA Games.
- 3.2. Preliminary Deadline for "Entry by Number"
Preliminary entry forms by number from each participating country, forwarded through the respective National Olympic Committee (NOC), must be completed and should be received by PhilSOC not later than 31 May 2005 at 2400 hours Philippine time (GMT +8).
- 3.3. Final Deadline for "Entry by Name"
The entry forms by name must be received by PhilSOC not later than 27 October 2005 at 2400 hours Philippine time (GMT +8).

4. Technical Meeting

The Technical Meeting of Managers from each participating country will announced two (2) days before the commencement of the competition. The time and venue of the meeting will be announced later.

COMPETITION GENERAL RULES & REGULATIONS

1. Technical Organization

The Philippine Badminton Federation is responsible for and has full control of the technical organization of the Badminton competition, in consultation with the International Technical Delegate when necessary.

2. Competition Format

2.1. Team Events Competition

2.1.1 Men's Team

- a. 3 Men's Singles
- b. 2 Men's Doubles

2.1.2 Women's Team

- a. 3 Women's Singles
- b. 2 Women's Doubles

2.2. Men/Women Individuals Competition

- 2.2.1.** 2 Men's Singles Entries
- 2.2.2.** 2 Pairs Men's Doubles Entries
- 2.2.3.** 2 Women's Singles Entries
- 2.2.4.** 2 Pairs Women's Doubles Entries
- 2.2.5.** 2 Pairs Mixed Doubles Entries

3. System of Competition / Rules

- 3.1. This Tournament shall be run according to the Rules and Regulation of the International Badminton Federation (IBF). Decisions in all matters shall rest with the Referee.
- 3.2. The Asian Badminton Confederation will confirm date for Seeding and date of Drawing by OC.
- 3.3. A Chief Referee shall come from a Neutral Country (Non-SEA Games Country) and at least two (2) Deputy Referees (One from Host Country and Another from one of the SEA Games Country) shall be appointed by the Asian Badminton Confederation for the duration of the competition.
- 3.4. The tournament shall be held in an Elimination System in those events where there are more than three (3) entries, otherwise it shall be held in a Round Robin System.
- 3.5. The losers of the semi-finals in all events will automatically rank third place.

3.6. Nomination of Team:

All players nominated shall be listed in order of current singles strength, intended doubles pairings shall be ranked in order of current as follows:

- 4 nominated players the 6 possible pairings
- 5 nominated players the 10 possible pairings
- 6 nominated players the 16 possible pairings

7 or 8 nominated players the 21 possible or most probable pairings
Each manager shall hand to the Referee at least 2 (two) hours before the start of any tie the composition of this team in the following order:

First Singles
Second Singles
Third Singles
First Doubles and
Second Double

These players shall be selected from those previously nominated and be in order as ranked.

The Referee may sanction a substitute for a player who in the opinion of the Referee is incapacitated by illness, accident or other unavoidable hindrance provided that the team that plays after the substitutions conforms to the initially nominated ranking order for singles or doubles.

3.7. Constitution of Ties and Team

Each tie shall be decided by the result of 3 (three) singles and 2 (two) doubles matches. However the Referee may decide not to play the last match or matches if the tie is already decided.

In singles, each team shall play its 3 (three) players according to their ranking order.

In double, each team shall play its 2 (two) pairs according to their ranking order. No player shall play in more than 1 (one) singles and 1 (one) doubles match.

3.8. Order of Play:

Any player participating in 2 (two) matches is entitled to an interval of 30 (thirty) minutes between them

These are 8 (eight) permissible order of play

- (1) First singles - first doubles - second singles - second doubles - third singles
- (2) First singles - second doubles - second singles - first doubles - third singles
- (3) First singles - second singles - first doubles - third singles - second doubles
- (4) First singles - second singles - second doubles - third singles- first doubles
- (5) First singles - second singles - third singles - first doubles - second doubles
- (6) First singles - second singles - third singles - second doubles - first doubles
- (7) First singles - first doubles - second singles - third singles - second doubles
- (8) First singles - second doubles - second singles - third singles- first doubles

The Referee may decide the order of play 1 to 8 will be considered in turn and the first order of play will be used which has no player playing in two consecutive or playing doubles before singles.

If all eight of play 1 to 8 result in a player playing in two consecutive or playing doubles before singles. Order of play 5 will be used.

4. Protests / Complaints

The Referee will decide all matters not covered by these Rules and Regulations

5. Officials

Each participating NOC may nominate an IBF licensed jury to officiate in the competition in accordance with the SEAGF Statutes and Rules

6. Equipment & Dress Code

The IBF Competition Regulations 14-19 (IBF Statutes 2005) on clothing color, design, lettering and advertising will apply.

PRIZES AND COMMENDATION

1. Victory Ceremonies

The Victory Ceremonies shall normally be held after the completion of each event. Participants receiving awards must wear official NOC uniform.

2. Prizes

a. Individual Events

First Prize: Gold Medal and Diploma to the winner in each event.

Second Prize: Silver Medal and Diploma to the athlete placed second in each event.

Third Prize: Bronze Medal and Diploma to the two losing semi-finalists in each event.

b. Team Events

First Prize: Gold Medal and Diploma to each member of the winning team.

Second Prize: Silver Medal and Diploma to each member of the team placed second.

Third Prize: Bronze Medal and Diploma to each member of the two losing semi-finalist teams.

There shall be no tie for gold, silver or bronze medal placing, except in events where there is no play-off between the losing semi-finalists for the bronze medal. Should there be a tie at the end of a competition for the gold, silver or bronze placing, a sudden death play-off shall be held to break the tie.
